Proposed Unit Development

A 351-unit apartment complex has been proposed on a 8.7 acre lot between Golden Corral and Taco Bell on West Stockton Blvd. Rezoning is required. The plan includes a gym, a pool and a clubhouse as well as the following:

- ~108 Studios,
- ~180 One bedroom,
- ~ 63 Two bedroom
- ~351 Parking Stalls
- ~All units will have washers and dryers
- ~No fireplaces
- ~Gas and electric utilities
- ~All first level floors will be handicapped accessible with a total of 8 handicapped parking spaces
